TERMS AND CONDITIONS

1. Definitions

In these terms and conditions, the term "Exhibitor" refers to any person, firm, or company applying for and granted space or sponsorship opportunities in the Sri Lanka Trade Fair Dubai 2024. The term "Exhibition" denotes the event specified in the Exhibition Participation Contract The term "Organizer" signifies the event producers, as identified in the Exhibition Participation Contract, or its assignees.

2 Application for Stand Space

2. Application for Stand Space (i) Application for stand Space at the Sri Lanka Trade Fair Dubal 2024 must be made on the Official Exhibition Participation Contract provided by the Organizers. The Organizer may, at its sole discretion, accept applications by purchase order in writing through post, telex, or fax, or accept a deposit payment in lieu of a written application. These Terms and Conditions apply to any such application, contracting the wreater and the Exhibitor. Until the completed Exhibition Participation Contract is received and accepted by the Organizer, the Organizer has the right, without notice, to reallocate the stand space to another exhibitor, rendering the booking null and void.

(ii) Upon acceptance of the Exhibition Participation Contract by the Organizer, a contract is established between the Organizer and Exhibitor, governed by these Terms and Conditions.

3. Allocation of Stand Space Every effort will be made by the Organizer to allocate the requested stand space. However, the Organizer reserves the right to make stand space reallocations, not exceeding 10% greater or less than the booked space, for effective Exhibition layout.

4. Payment

All payments must comply with the terms and methods outlined in the Exhibition Participation Contract. Failure by the Exhibitor to meet payment obligations allows the Organizer to cancel the contract, resell, or reallocate the stand space, subject to the cancellation charges mentioned in paragraph 5.

5. Cancellation of Participation (i) The Exhibitor may cancel or reduce participation by providing written notice, stating reasons, via Recorded Delivery post. The Organizer, at its discretion, may accept or reject the cancellation notice. (ii) Upon acceptance of the cancellation notice, the Organizer may apply cancellation charges:

From the contract signature: 50% of the total cost

2. Within 120 days of the event: 100% of the total cost

(iii) The Exhibitor acknowledges that these charges represent reasonable compensation for costs incurred and are not

6. Reduction of Space

If the Exhibitor notifies the Organizer of a reduced stand space, the Organizer may resell or reallocate the space, applying cancellation charges based on the reduction.

7. Stand Space and Exhibits

(i) The Exhibitor must occupy allocated space by the show opening time on the first day. Failure to do so allows the Organizer to lessen or relocate the space, and cancellation charges apply.

(ii) The Exhibitor may only use Contractors other than the official stand contractors with the prior consent of the Organizer.

(iii) Plans for specially built stands require approval from the Organizer before construction.

(iv) The Organizer may charge for additional space occupied beyond the allocated space.

(v) The Exhibitor may exhibit only items specified in the Exhibition Participation Contract.

(vi) Exhibits must not obstruct other Exhibitors' displays.

(vii) The Organizer may alter the layout, position, or stand number without notice.

(viii) The Organizer has access to the Exhibitor's stand before, during, and after the Exhibition.

(ix) Disputes regarding stand allocation will be resolved by the Organizer.

8. Exhibitor's Representative and Passes

(i) The Exhibitor must supply the name of at least one representative for installation, operation, and removal of exhibits.

(ii) Non-transferable passes will be issued for official access to the Exhibition areas.

9. Duration of Exhibition

Stands must be manned during Exhibition hours. The Exhibitor must be ready to conduct business during these times.

10. Removal of Exhibits

(i) No exhibit shall be removed before the Exhibition's closing without written permission. Breach results in ensation to the Organizer.

(ii) The Organizer may require removal of exhibits not specified in the Exhibition Participation Contract.

(iii) The Exhibitor is liable for storage and handling charges for failure to remove exhibits.

(iv) The Exhibitor must surrender occupied modular or shell scheme packages in original condition.

11. Attendance

(i) The Organizer is not responsible for other exhibitors' failures to attend or visitor attendance.

(ii) Exhibition Space Contract is not conditional on the presence of other exhibitors.

12. Exclusion of Personnel

The Organizer may exclude or remove any person deemed undesirable, regardless of association with the Exhibitor

13 Undesirable Activities

13. Undestrative Activities If the Organizer perceives that the Exhibitor is engaged in activities contrary to the Exhibition's best interests, unethical, or in violation of the law, the Organizer may cancel the stand space allocation, require immediate vacation of the allocated space, and deny further participation without liability for refund or charges abatement.

14. Fire Precautions and Dangerous Materials

All materials on building or covering stands must be non-flammable. Exhibitors must adhere to authorities' instructions to prevent fire or other risks. The Exhibition prohibits explosives, dangerous substances, and materials.

15. Compliance with Regulations Exhibitors must comply with all requirements, laws, rules, and regulations imposed by the Organizer, Exhibition building proprietors or managers, and municipal authorities.

16. Electric Lighting and Power (i) If the Organizer appoints official contractors for electrical work, the Exhibitor is responsible for settling accounts directly with the contractor for electrical work and consumption. (ii) Electrical installations must comply with statutory or local regulations. Exhibitors must screen direct light to avoid inconvenience to visitors and other exhibitors.

17. Insurance

(i) Exhibitors must carry public liability insurance against personal injury, death, or property damage. Failure to provide proof of insurance may result in stand space cancellation, with the right to resell or reallocate the space. (ii) Exhibitors must have indemnity insurance covering loss, damage, or injury to goods and persons.

18. Cancellation or Change of Location or Date of Exhibition (i) The Organizer may cancel, relocate, or change the Exhibition's date or part thereof at its discretion. Refunds, if any, are at the Organizer's absolute discretion, proportionate to the aggregate exhibit fees, deducting expenses and reasonable compensation.

(ii) Exhibitors have no right to refunds, damages, or expenses in case of cancellation under specific circumstances

(iii) If the Organizer cancels the Exhibition for commercial reasons, all payments made will be refunded, with no further claims against the Organizer.

19. Default and Exhibitor's Insolvency If the Exhibitor breaches obligations, goes bankrupt, ceases business, or undergoes insolvency proceedings, the Organizer can terminate the contract, resell or reallocate stand space, applying cancellation charges. Payments made are non-refundable.

20. Limitation of Liability

20. Limitation of Liability (i) The Organizer, its employees, or agents are not liable for loss, theft, damage, or injury to persons or property. (ii) Information provided by the Organizer is accurate to the best of its knowledge but does not constitute a warranty or representation. The Organizer is not liable for mistakes or omissions. (iii) The Organizer may amend promotional strategies without liability for statements made regarding audience projections or promotion methods.

21. Indemnity (i) The Exhibitor indemnifies the Organizer against costs, claims, demands, and losses arising from the Exhibitor's participation in the Exhibition. (ii) If the Exhibitor is a limited company, its directors undertake to indemnify the Organizer against liabilities resulting from damage or injury caused by the Exhibitor, its employees, or agents.

22. Assignment The Exhibitor cannot assign or delegate rights or obligations arising under these Terms and Conditions. The Organizer can assign its contract with the Exhibitor without notice.

23. Entire Agree These Terms and Conditions constitute the entire agreement between the Organiser and the Exhibitor, subject to changes in writing signed by authorized representatives.

24. Governing Law and Jurisdiction

24: Soverning Law and Darisdiction (ii) Dispute between the Organizer and Exhibitors are settled in Sri lanka Civil Court. (iii) The Organizer may sue any Exhibitor before their national court or any other court at its discretion. (iii) Exhibitors are bound by applicable regulations for fairs and exhibitors in Sri lanka. (iv) Sri lanka Law governs the contract between Exhibitors and Organizers.
